Anti-Human Trafficking Programs Implements laws to combat human trafficking, coordinates training for prosecutors, judges, law enforcement officers and juvenile services; provides supports to programs serving victims; consults on regulations and legislative initiatives; and consults with other agencies to promote awareness and education programs for professionals and for the public to enhance prevention and protection of victims. This program also assists with coordination of the Human Trafficking Advisory Board.

Batterer's Intervention Program Certification Provides training regarding best practices for batterer intervention programs, collaborates with other statewide agencies to increase both victim safety and perpetrator accountability through effective systemic response, and is responsible for the certification of batterer intervention programs.

Safe at Home Provides a substitution address for victims of domestic violence, sexual violence, stalking and trafficking to use on all public records as well as a free first-class mail forwarding system for participants. It is the official address confidentiality program of Kansas.

Victims Grants Administers state funded grants provided to victim service agencies located throughout Kansas. Child exchange and visitation centers, child advocacy centers, domestic violence or sexual assault programs, and other crime victim service agencies may apply to one or more of the following funds: 1) Protection From Abuse Fund, 2) Crime Victim Assistance Fund, 3) Crime Victim Assistance Fund for Child Abuse and Neglect, 4) Child Advocacy Center Fund, 5) Child Exchange and Visitation Center Fund, and 6) Human Trafficking Victim Assistance Fund.

Kansas VINE is an automated victim notification service providing real time information regarding custody status of offenders held in 94 county jail facilities. Kansas VINE is a free and anonymous telephone, mobile app, and online service that provides the public the ability to search for the current custody status on an incarcerated offender in a county jail. Kansas VINE also provides the option to register to receive notifications when a change in custody status occurs such as release from custody or transfer to another facility. Kansas VINE does not include the Kansas Department of Corrections offenders housed in state prisons, juvenile offenders, or federal detainees.

Kansas Crime Victims Compensation Board Provides victims with financial assistance for loss of earnings and out-of-pocket loss for injuries sustained as a direct result of violent crime. Eligible expenses include reasonable medical care, mental health counseling or other services necessary as a result of the injury. In the event of the death of the victim, reasonable medical expenses and the partial cost of funeral, burial or cremation is reimbursable. Personal property loss is not covered, with the exception of clothing and bedding seized as evidence, or property that had to be removed during the crime scene clean-up process.

- *Victims can also register to receive automated notifications when an offender’s custody status changes. Notifications are delivered via telephone, email, text message, and in-app. TTY (hearing impaired) service is also available.*
- *Kansas VINE Service is available in English and Spanish. Kansas VINE print materials are available in English and Spanish.*
- *Kansas VINE search and notification is specific to offenders housed in county jails. Kansas VINE does not include the Kansas Department of Corrections offenders housed in state prisons, juvenile offenders, or federal detainees.*

Victims' Bill of Rights (K.S.A. 74-7333)

1. Victims should be treated with courtesy, compassion and with respect for their dignity and privacy and should suffer the minimum of necessary inconvenience from their involvement with the criminal justice system.
2. Victims should receive, through formal and informal procedures, prompt and fair redress for the harm which they suffered.
3. Information regarding the availability of criminal restitution, recovery of damages in a civil cause of action, the crime victims' compensation fund and other remedies and the mechanisms to obtain such remedies should be made available to victims.
4. Information should be made available to victims about their participation in criminal proceedings and the scheduling, progress and ultimate disposition of the proceedings.
5. The views and concerns of victims should be ascertained and the appropriate assistance provided throughout the criminal process.
6. When the personal interests of victims are affected, the views or concerns of the victim should, when appropriate and consistent with criminal law and procedure, be brought to the attention of the court.
7. Measures may be taken when necessary to provide for the safety of victims and their families and to protect them from intimidation and retaliation.
8. Enhanced training should be made available to sensitize criminal justice personnel to the needs and concerns of victims and guidelines should be developed for this purpose.
9. Victims should be informed of the availability of health and social services and other relevant assistance that they might continue to receive the necessary medical, psychological, and social assistance through existing programs and services.
10. Victims should report the crime and cooperate with law enforcement authorities.

Kansas Constitutional Amendment for Victims' Rights

Article 15, Section 15 of the Constitution of the State of Kansas reads as follows:

Victims' Rights. (1) Victims of crime, as defined by law, shall be entitled to certain basic rights, including the right to be informed of and to be present at public hearings, as defined by law, of the criminal justice process, and to be heard at sentencing or at any other time deemed appropriate by the court, to the extent that these rights do not interfere with the constitutional or statutory rights of the accused.

(b) Nothing in this section shall be construed as creating a cause of action for money damages against the state, a county, a municipality, or any of the agencies, instrumentalities, or employees thereof. The Legislature may provide for other remedies to ensure adequate enforcement of this section.

(c) Nothing in this section shall be construed to authorize a court to set aside or to void a finding of guilty or authorize a court to set aside or to void a finding of guilty or not guilty or an acceptance of a plea of guilty or to set aside any sentence imposed or any other final disposition in any criminal case.
