This was the site of a prior burglary and the suspicious characters were both a white male and black males. No indicators of bias and complaint was exonerated.
18-FI7823	4/14/18	Investigated and Unfounded. This was a 3rd party allegation.	4/17/18	A officer was investigating a parked car in an area in which a large number of thefts from vehicles had occurred. A black male was observed inside of a parked vehicle with the dome light on at approximately 2:00 a.m. Officers subsequently found the man to be the owner of the car. A third party alleged he was investigated because of his race. After investigation the allegation was unfounded and appeared to be proper investigative police work.
