In addition to external partners, the ANE Unit, within the Victim Services Division, frequently utilizes the expertise and resources supplied by other divisions of the Office of the Kansas Attorney General. The ANE Unit relies on the cooperation and partnership of one and all to improve the response to vulnerable adults and children in Kansas. K.S.A. 75-723
Chapter 75.—STATE DEPARTMENTS; PUBLIC OFFICERS AND
EMPLOYEES

Article 7.—ATTORNEY GENERAL

75-723. Abuse, neglect and exploitation unit; confidentiality of investigations; reports forwarded to unit; report to legislature; rules and regulations; prohibition on use of funds; contracting. (a) There is hereby created in the office of the attorney general an abuse, neglect and exploitation of persons unit.

(b) Except as provided by subsection (h), the information obtained and the investigations conducted by the unit shall be confidential as required by state or federal law. Upon request of the unit, the unit shall have access to all records of reports, investigation documents and written reports of findings related to confirmed cases of abuse, neglect or exploitation of persons or cases in which there is reasonable suspicion to believe abuse, neglect or exploitation of persons has occurred which are received or generated by the department of social and rehabilitation services, department on aging or department of health and environment.

(c) Except for reports alleging only self-neglect, such state agency receiving reports of abuse, neglect or exploitation of persons shall forward to the unit:

(1) Within 10 days of confirmation, reports of findings concerning the confirmed abuse, neglect or exploitation of persons; and

(2) Within 10 days of such denial, each report of an investigation in which such state agency was denied the opportunity or ability to conduct or complete a full investigation of abuse, neglect or exploitation of persons.

(d) On or before the first day of the regular legislative session each year, the unit shall submit to the legislature a written report of the unit's activities, investigations and findings for the preceding fiscal year.

(e) The attorney general shall adopt rules and regulations as deemed appropriate for the administration of this section.

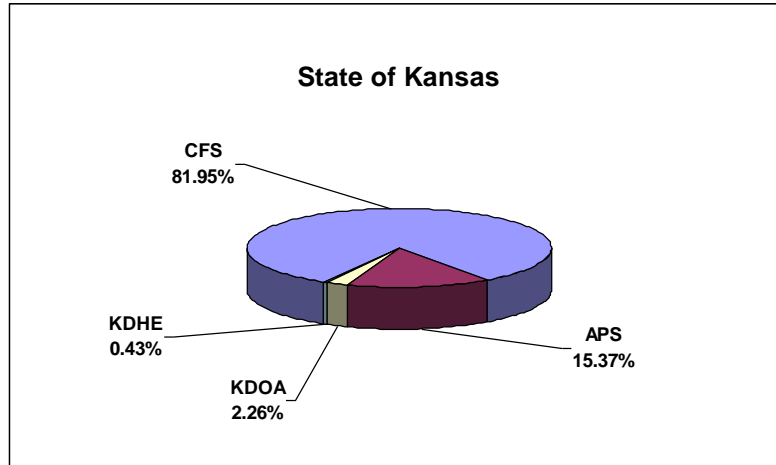
(f) No state funds appropriated to support the provisions of the abuse, neglect or exploitation of persons unit and expended to contract with any third party shall be used by a third party to file any civil action against the state of Kansas or any agency of the state of Kansas. Nothing in this section shall prohibit the attorney general from initiating or participating in any civil action against any party.

(g) The attorney general may contract with other agencies or organizations to provide services related to the investigation or litigation of findings related to abuse, neglect or exploitation of persons.

(h) Notwithstanding any other provision of law, nothing shall prohibit the attorney general or the unit from distributing or utilizing only that information obtained pursuant to a confirmed case of abuse, neglect or exploitation or cases in which there is reasonable suspicion to believe abuse, neglect or exploitation has occurred pursuant to this section with any third party contracted with by the attorney general to carry out the provisions of this section.

ACTIVITIES, INVESTIGATIONS, FINDINGS

For the period of July 1, 2007 to June 30, 2008 the ANE Unit received 1640 reports of substantiated or confirmed abuse, neglect or exploitation from Kansas Department of Social and Rehabilitation Services (SRS), Kansas Department on Aging (KDOA) and Kansas Department of Health and Environment (KDHE). The reports consisted of 1344 from SRS Children and Family Services (CFS), 252 from SRS Adult Protective Services (APS), 37 from KDOA, and 7 from KDHE.



SRS Children and Family Services (CFS) - Social workers investigate reports of child abuse, including physical injury, physical neglect, emotional injury or sexual acts inflicted upon a child. <http://www.srskansas.org>.

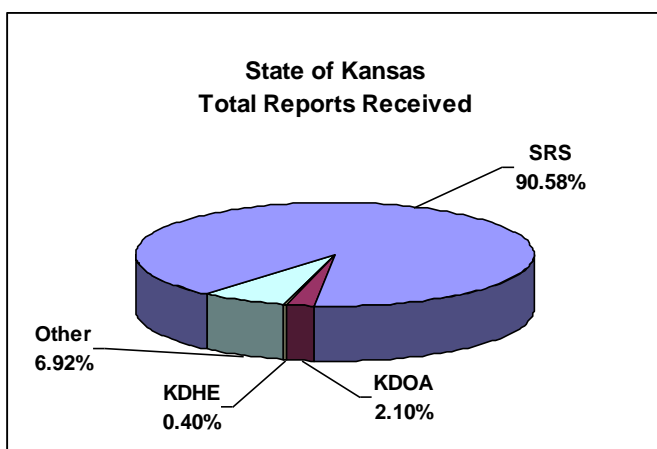
SRS Adult Protective Services (APS) - Social workers investigate reports and provide protective services to adults, with their consent, who reside in the community, adults residing in facilities licensed/certified by Social and Rehabilitation Services, and to adults residing in adult care homes and other facilities licensed by the Kansas Department on Aging, when the alleged perpetrator is not a resident or employee of the facility. APS also investigates caregivers providing services to home and community based service (HCBS) clients. <http://www.srskansas.org>.

KDOA - Investigates reports of adult abuse, neglect and exploitation occurring in adult care homes (ACH). Examples: nursing home facilities, assisted living facilities, boarding care. <http://www.agingkansas.org/>

KDHE - Investigates reports of adult abuse, neglect and exploitation occurring in medical facilities and non-long term care facilities. Examples: hospitals, ambulatory surgery centers, home health agencies, hospice, rural health clinics, outpatient physical therapy, portable x-ray units. <http://www.kdheks.gov>

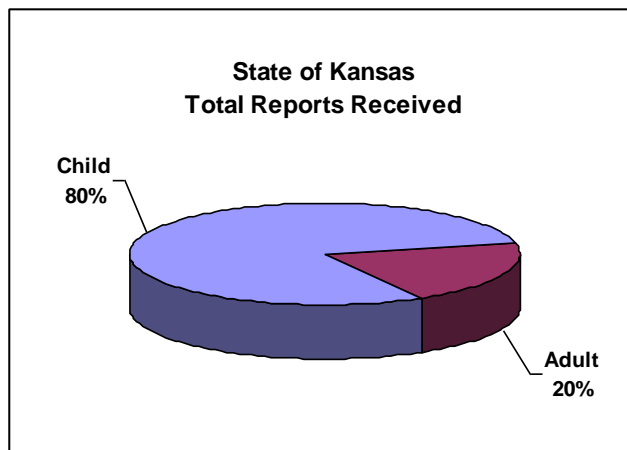
Abuse, Neglect & Exploitation (ANE) Unit Report
July 1, 2007 – June 30, 2008

In addition to the reports of confirmed or substantiated abuse, the ANE Unit also receives “other” reports where investigations may have been originally denied or hindered. These reports come from law enforcement, SRS, KDOA, KDHE, legislators, or private citizens. The ANE Unit frequently receives complaints, concerns, or simply questions from the public. For the period of July 1, 2007 to June 30, 2008 the ANE Unit received 122 “other” reports. Of the 122 “other” reports, 67 were child abuse related and 55 were adult abuse related. Reports of confirmed or substantiated abuse combined with “other” reports reviewed accounted for a total of 1411 reports of child abuse and 351 reports of adult abuse for a total of 1762 cases. Reports can involve more than one victim and/or more than one perpetrator.



More than 90 % of the reports received by the ANE Unit originated with either SRS Children and Family Services (CFS) or Adult Protective Services (APS). Almost 7% came from various “other” sources, slightly more than 2% came from KDOA, and less than 1% were from KDHE.

Child ANE comprised 80 percent of all reports received. The remaining reports were on vulnerable adults over age 18.



In situations where unreported abuse is alleged, persons contacting the ANE Unit are encouraged to report directly to the proper investigative entity. When appropriate, referrals are made to the correct protection reporting center and to local law enforcement.

Complaints and concerns are explored to determine whether a report was received by the appropriate agency and the investigation is progressing as expected or could be aided by intervention.

The ANE Unit regularly serves as a liaison, coordinating with local law enforcement, county and district attorneys, SRS, KDOA, KDHE and the general public as is possible within state and federal confidentiality restrictions. This exchange provides an important constituent service and oversight function. The process allows for considerable insight into the functioning of each partner and often serves to educate the public as to roles and responsibilities of each.

The ANE Unit consistently informs citizens that information obtained as a result of inquiries on their behalf cannot be shared with them. The follow up completed regarding their report does provide a source of collateral information and an outlet for their concern. The interaction and follow up information obtained also serves to help assess the impact of current policies and procedures on victims and their families.

Ongoing discussions are held with state agency representatives to review policies, practices and procedures and to discuss system improvement and staff performance.

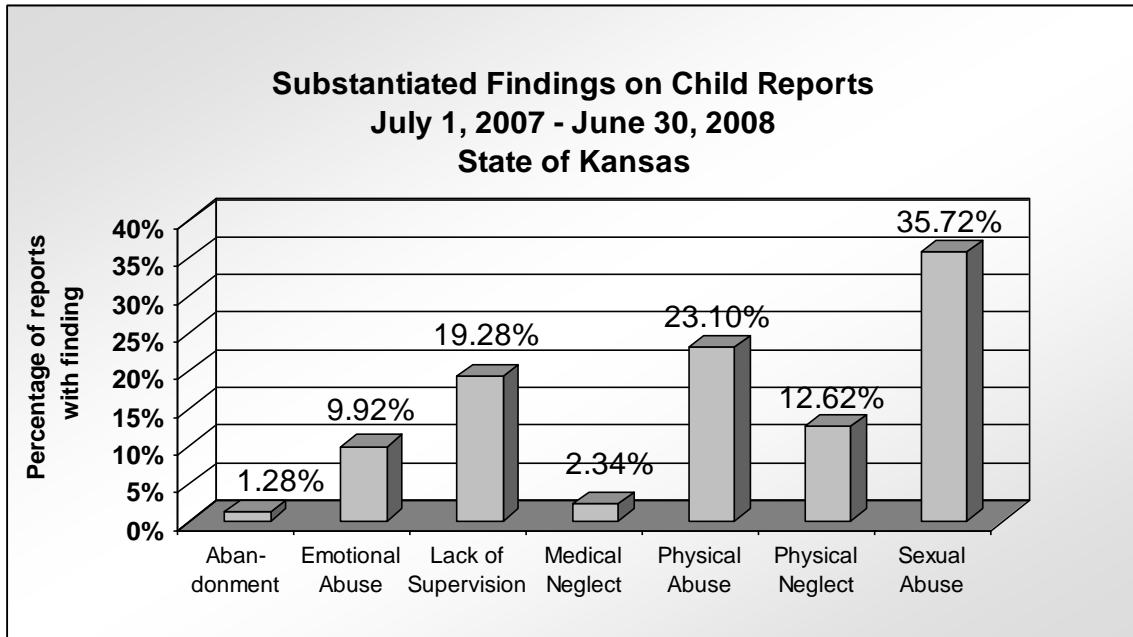
July 1, 2007 to June 30, 2008 marked the second year of the ANE Unit's existence. Progress toward establishing working relationships and developing consistent reporting to meet statutory requirements continues. The ANE Unit would not be serving the citizens of Kansas should it simply serve as a rubber stamp for work already completed. Our inquiries reveal that there is need for system improvement and for the continued education and development of individuals who work within it. At the same time it is important to clearly state that the vast majority of cases reviewed were handled within an expected range of outcomes.

ANE investigations are complex; a single element can vary the route a case may take. The multiple disciplines who are involved in an investigation approach the case from different perspectives and pursue different objectives. The community where the case originates has its own influence on the outcome. While the state of Kansas has one set of laws and the agencies have set policy and procedures, the necessary discretion afforded each different entity involved can make two similar situations have very different outcomes.

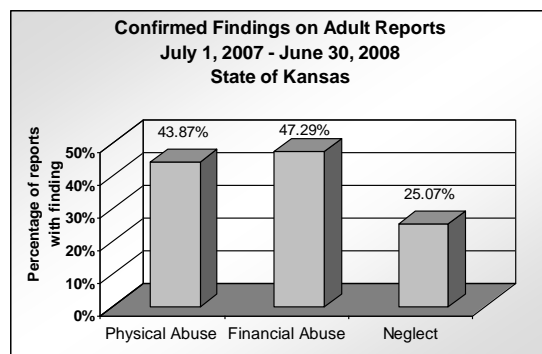
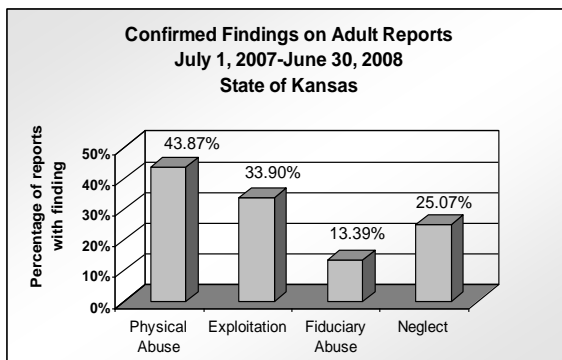
To provide effective response to victims of ANE, each discipline must work diligently to fulfill their own role and respect the others' positions and viewpoints. It is seldom fitting for a member of one discipline to tell another how to do their job – or not to do their job – or prevent them from having necessary information.

Abuse, Neglect & Exploitation (ANE) Unit Report
 July 1, 2007 – June 30, 2008

Findings recorded for the 1344 substantiated reports of child abuse include abandonment, emotional abuse, lack of supervision, medical neglect, physical abuse, physical neglect, and sexual abuse. Some reports contained substantiations of more than one type of abuse. Sexual abuse was the most frequently substantiated form of abuse.



Findings recorded for the confirmed reports of adult abuse include physical abuse, exploitation, fiduciary abuse, and neglect. Some reports contained confirmations of more than one type of abuse. Nearly all the exploitation reports were related to financial exploitation. Fiduciary abuse is another type of financial abuse. It is distinguished by the perpetrator being a person who stands in a position of trust, very often someone given power of attorney. By combining both financial exploitation and fiduciary abuse, the most frequently confirmed type of abuse was financial abuse of vulnerable adults, most often seniors. Financial abuse was followed closely by physical abuse.



The following are examples of investigations that were originally denied or hindered, with which the ANE Unit became involved to improve the outcome:

- In numerous cases the ANE Unit obtained and facilitated delivery of information that was needed by SRS, KDOA, KDHE, local law enforcement, or county or district attorney to assure that the case received full consideration
- Abuse reports to SRS where a crime had occurred or appeared to have occurred were not originally forwarded to law enforcement to determine if criminal investigation was warranted. ANE Unit involvement ultimately resulted in further criminal investigation and charges in some cases.
- Retrospective disclosure had not been provided to law enforcement or local prosecutor; additional disclosure by children after being placed in custody provided information local law enforcement and the prosecutor needed to file criminal charges.
- Abuse reports provided to SRS were not further provided to KDHE as required by statute. ANE Unit involvement ultimately resulted in licensure action in some instances.
- Reports of child or adult abuse were made to SRS or KDOA and no visible action could be determined by reporter. This occurred regarding abuse in the community, in nursing homes, in group homes and in foster care settings. ANE Unit involvement contributed to various additional outcomes, including criminal charges. However, the majority of reports had been assessed and investigated as would be expected within statute, regulation, and policy.
- A child was found to have been removed from home by law enforcement, and kept out of the home with no court proceeding and no services in place to facilitate the child's return to the home. After ANE Unit inquiry, the child was returned home with family preservation services in place.
- SRS made referrals to the local county or district attorney to review for a child in need of care petition, but did not always make a referral to the county where an alleged crime occurred for potential criminal charges. ANE Unit involvement resulted in further criminal investigation or charges in some cases.
- Persons reported abuse concerns for children in custody directly to SRS staff or contractor staff, but the individual believed the report may not have been forwarded or no investigation had occurred. Persons also reported

adult care setting abuse they felt was known to mandated reporters who had failed to report. Follow up in this area found that in the majority of instances the abuse had been reported, assessed and investigated as would be expected. In those few cases where no report was found, ANE Unit involvement provided the means to generate an intake to the SRS Protection Reporting Center or to KDOA and follow up was completed by the ANE Unit to determine the resolution of the report.*

* Depending on the known circumstances, various actions can be taken. Evident failure of a mandated reporter to report suspected abuse will be referred for further investigation by licensing boards, local law enforcement, or to the local county or district attorney for consideration of prosecution. The ANE Unit made no such referrals in the current reporting year.

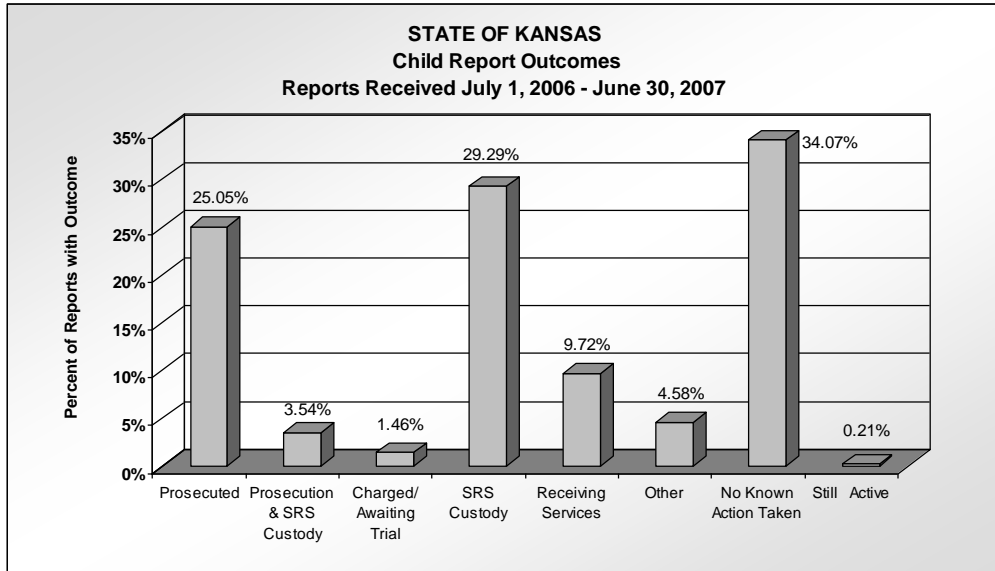
A Note of Commendation

A large number of ANE Unit contacts are with SRS staff as SRS provides 97% of all the substantiated or confirmed abuse, neglect or exploitation reports to the ANE Unit. SRS staff responds to most ANE requests within 48 hours and many the same day. This cooperation is appreciated and indicates a dedication to increase safety and response to children and adults who are victims of abuse.

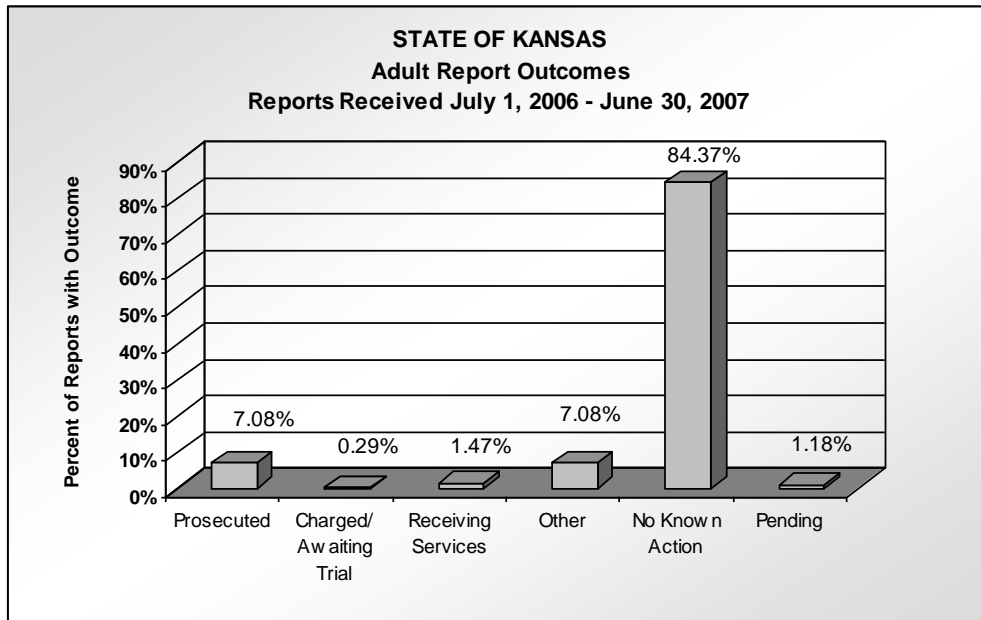
Abuse, Neglect & Exploitation (ANE) Unit Report
 July 1, 2007 – June 30, 2008

While the bulk of reports come into the ANE Unit from substantiated or confirmed findings reported by the investigating agency, those situations where a finding has not been made or where the case may still need further investigation create the bulk of the work. Original findings are recorded and cases are tracked for outcomes. Disposition information is primarily obtained through direct contact with the agencies, prosecutors' offices and through online court information.

CONCERNS, RECOMMENDATIONS

Investigation of Alleged Abuse of Children in State Custody

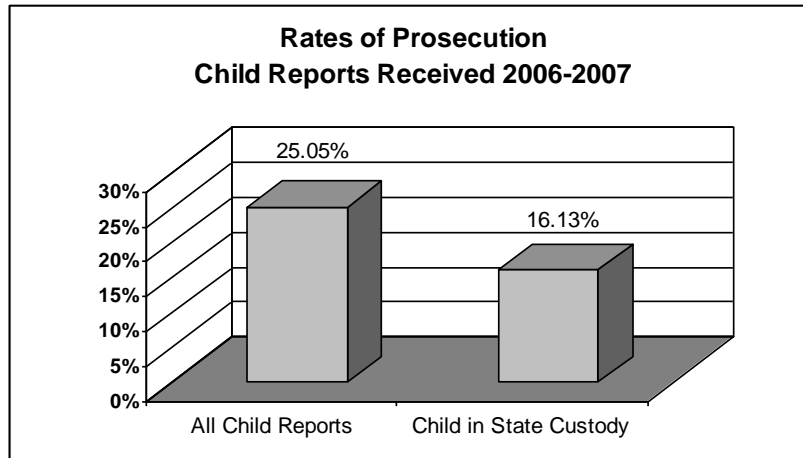
Of concern to the ANE Unit were situations in which either the victim or the perpetrator were already in state custody at the time of substantiated abuse, neglect and/or exploitation. In two cases reviewed involving abuse investigations in residential facilities, the ANE Unit noted no interview of staff who directly witnessed the event. Law enforcement was not called by facility personnel in either case, and in one case the facility significantly delayed SRS notification. In both cases, SRS investigators accepted details from senior staff and management instead of directly interviewing staff on duty at the time of the event. In one of the cases the SRS investigator was not provided logs or other documentation by facility management until over 30 days after the event.

The preliminary investigation by SRS can provide information that is then given to law enforcement to help determine whether further criminal investigation is warranted. It is important that staff on duty and providing direct care or supervision of the child at the time of the incident be interviewed by the investigators in person. The victim and all other witnesses should be interviewed. Facility documentation leading up to, at the time of, and subsequent to the event should be provided to investigators immediately upon request.

In some cases where children were in state custody, the ANE Unit found that SRS investigators relied on contractor staff to provide information instead of seeing the child and interviewing witnesses in person. There is a purposeful separation in roles between the contractors providing foster care services and SRS who is mandated to investigate child abuse. The separation should be maintained during an investigation to avoid any conflict of interest. SRS willingness to accept second hand information has been seen outside facility situations as well. This has sometimes contributed to a failure to complete a thorough investigation. The child victim should be interviewed, the alleged perpetrator should be offered an interview, and other witnesses should be interviewed in person within the established policy and timeframes. Interviews should be well documented and should be maintained as part of the case file.

Lower Prosecution Rates of Child Abuse Occurring in State Custody

The ANE Unit did note lower than average child abuse prosecution rates when children already in state custody are victims of abuse, as shown by the Rates of Prosecution chart on the following page.



Often, children in custody are moved to a new placement immediately upon initiation of an abuse investigation. Victims, other child witnesses, and even the alleged perpetrator may be moved out of the county where the crime occurred. Although some of these moves may be needed to ensure safety, this makes both investigation and prosecution more difficult. The child victim may not have been a resident of the county where the crime occurred. Therefore, even if the birth parents are made aware of the details surrounding the abuse, which does not appear to have occurred in the cases we reviewed, they have few connections in that community to advocate for filing charges. Protocols for investigations, including moving children when abuse allegations arise, should be developed to address the immediate safety requirements that often exist as well as the ongoing criminal justice needs.

The ANE Unit views prosecution as a form of prevention. Holding perpetrators accountable through the criminal justice system sends a message the behavior is wrong and sometimes takes the perpetrator out of the home, allowing the child to stay with a non offending caretaker. Too often, however, a child victim is victimized a second time by being taken from the home and placed in foster care, while the perpetrator is allowed to stay in the home with no criminal prosecution pursued. Child victims often are told by abusers that the child will be the one to leave if the child "tells." Sadly, the very thing abusers may have told the child would happen does occur in some cases.

Many factors enter into the ability to prosecute a case of child abuse. Statewide, the average prosecution rate for substantiated child cases is 25.05%. Special units consisting of law enforcement and social worker teams can create, higher than average prosecution rates. For example, Sedgwick County has the Exploited and Missing Children Unit (EMCU) and a 33.18% child abuse prosecution rate for 2006-07.

Placement Decisions for Children in State Custody

The ANE Unit found a number of instances where children known to have exhibited sexual aggression or sexual behaviors toward other children were placed in foster homes or residential facilities without individualized safety plans to reduce risk to other children in care.

In some cases of substantiated sexual abuse by a child perpetrator, the perpetrator was determined a child in need of care and no prosecution pursued. The result in many of those cases was that the perpetrator was placed in state custody, out of home, in a least restrictive environment. For the safety of other children, child perpetrators substantiated for sexual abuse need to be placed in a home where no other children are present.

The ANE Unit received multiple reports where youth previously substantiated for sexual abuse while in their own homes, or in state custody, went on to reoffend while still in care. When the ANE Unit made inquiries to determine whether a child with known sexual behaviors had been placed in settings with other children, the concern elicited varied responses. One case involved a youth released from inpatient sex offender treatment with specific recommendations for safety, one of which was that the child not be placed with other children. The regional contractor providing foster care services rejected written treatment release recommendations and placed the youth in a home with other children. ANE Unit request for confirmation of a safety plan was met with nearly a two month delay.

Placement decisions and safety planning need to be looked at closely, with immediate correction of any lack of conformity with statute, regulation, policy, or known best practice.

☆ **Gold Star** *“Health, safety and well-being of children in out of home care”*

While the overall preference is for children to be maintained in their own homes, there are situations that require out of home care. KDHE is responsible for regulatory enforcement that can impact licensing of a foster home, residential facility or childcare center. KDHE response involving child abuse substantiations by SRS, having occurred in KDHE licensed facilities, showed the most consistently applied practice and procedure, matching statute, regulation, and policy. This oversight by an agency with no vested interest in the individual child cases or foster home sponsorship provides for a neutral perspective when applying regulation and making determinations for the health, safety and well being of children in out of home care. It is important our state maintain this level of protection for children in state custody.

***Mandated Reporting and Collaboration between Agencies
in both Child and Adult Cases***

Consistent reporting and collaboration are critical for improving outcomes in ANE cases. The information indicating a crime or what appears to be a crime should be provided to local law enforcement immediately as required by state statute. Local law enforcement then has the discretion to determine whether any action is warranted with regard to a criminal investigation. The ANE Unit found numerous instances where criminal events had not been reported to law enforcement for prompt determination whether further action was warranted.

SRS may make an administrative finding that would place a person confirmed or substantiated of abuse on an abuse registry, providing some deterrence to reoffending and a possible barrier to some types of employment. However, abuse reports involving a criminal element must be reported immediately to law enforcement to aid in a thorough criminal investigation. The ANE Unit confirmed through follow up that reports were not consistently made to law enforcement. Delays sometimes compromised the criminal investigation. These instances included both child and adult abuse allegations. However, the mechanisms in place for addressing child abuse appear to be more consistent in this regard than was found with adult reporting.

The lack of reporting concern was brought to the attention of SRS. In an effort to help ensure reporting to law enforcement, SRS APS developed a two stage process this past year. The first stage occurred at the protection reporting center. Reports indicating what appeared to be a crime were to be immediately provided to local law enforcement. The second stage, that of reporting additional information to law enforcement, was to occur at any point during an investigation by SRS, including at its completion. ANE Unit follow up indicates that the protection reporting centers briefly increased reporting to law enforcement, but reverted back to inconsistent reporting.

ANE follow up also points to some increase in reporting to law enforcement by individual APS social workers with regard to this second stage. Additional training is scheduled to further assist APS workers in recognizing the required and relevant information to be forwarded to law enforcement for consideration. These cases can be very difficult to investigate and prosecute under optimum circumstances. Any delay or action that may compromise evidence needed for possible prosecution is a problem for law enforcement and prosecutors, and lack of prosecution can be a disappointment to SRS staff and victims. As per statute, all crimes are to be reported to law enforcement.

In addition to reports not being forwarded to law enforcement, numerous instances were found in which reports were not made by law enforcement to SRS or KDHE as required by statute. Numerous situations exist that do not rise

to the level of being criminal in nature but can still be addressed through service referrals made by SRS or through licensure action by KDHE.

Continued training for all parties to better understand each other's roles and responsibilities within the total response to victims of abuse is imperative. A willingness to participate and then apply that knowledge is essential. In addition to providing technical assistance and policy development leadership to state agencies, the Office of Attorney General will look for ways to directly and indirectly provide increased opportunities for continued education to the professionals working with abuse, neglect and exploitation cases.

Prosecution of Confirmed Adult Abuse

The statewide prosecution rate for cases of adult abuse confirmed by SRS APS or KDOA was just over 7%. Adult abuse, neglect, and exploitation cases are complex and cannot be fully addressed without collaboration. As the ANE Unit conducted report inquiries, individuals within the various agencies expressed genuine interest in collaboration. At the same time, frustration was often voiced regarding the inability to get needed information from other entities involved. Where it is not already occurring, it is recommended that each county form a multidisciplinary group to, at the very least, begin a dialog regarding each other's needs, resources and services. These local groups can best form plans to increase recognition, reporting, investigation, prosecution and other forms of response to adult abuse in their own communities.

Financial Exploitation of the Elderly

The 2006-2007 ANE Unit report identified fiduciary abuse or financial exploitation of the elderly as a significant concern. Since that time, multiple units and divisions within the Office of the Attorney General united in efforts to increase recognition, reporting, investigation, and prosecution of these crimes against our senior citizens. State partners, including SRS, KDOA, KDHE and service providers, have supported awareness activities. Financial institutions and their state associations are being proactive in development of and participation in additional training to address elder abuse. Counter cards for financial institutions created as a result of this effort may currently be requested from the Office of the Attorney General. The counter cards provide tips for seniors and tellers to help them recognize abuse and know how to report it. The Kansas County and District Attorney Association (KCDAA) hosted an educational session at their 2008 Fall Conference with additional sessions planned for the 2009 Spring Conference. During the July 1, 2007 to June 30, 2008 year, confirmed reports received by the ANE Unit show that financial abuse, including both exploitation and fiduciary abuse, account for half of all confirmed findings of abuse on adults

in Kansas. Numerous public and private businesses and groups continue to collaborate on multiple events and activities at state and local levels to make sure our loved ones are protected and these crimes are taken seriously.

Closing Statement



In most situations reviewed, new policy, procedure, or new legislation is not viewed as the solution. It would be our recommendation that ongoing cross training be completed to allow everyone a better understanding of their own, and others', roles within the system. We must all realize that what we do, as well as what we don't do, has an impact on victims. It would be our hope that each entity and individual addressing abuse, and the situations that often occur as a result, strive to hold themselves and others accountable for best practices in all disciplines. Being able to better protect and serve our most vulnerable citizens depends on it.
